



## Village Farms International Reminds Shareholders to Cast Annual Meeting Votes

("Village Farms" or "the Company") (NASDAQ: VFF) reminds shareholders to exercise their voting rights for the Company's upcoming annual meeting, which will be held virtually on Friday, June 28, 2024 at 12:00 p.m. Eastern time ("the Meeting").

### Online Voting

Many shareholders can quickly and easily cast their vote **online** in advance of the Meeting by going here [www.investorvote.com](http://www.investorvote.com) and entering the "control number" that was included in the Meeting materials package emailed from their brokerage firm. The deadline for advanced voting is 12:00 p.m. (Eastern time) on June 26, 2024.

### Other Methods to Vote

Shareholders can also vote in advance of the Meeting by signing and returning their form of proxy (for registered shareholders) or voting instruction form (for non-registered shareholders) to the Company's registrar and transfer agent, Computershare Investor Services Inc. ("Computershare") prior to the aforementioned deadline:

- **By mail** using the return envelope addressed to Computershare Investor Services Inc. ("Computershare") at their offices located at 100 University Avenue, 9th Floor, Toronto, ON M5J 2Y1; or,
- **By fax** at 1-800-517-4553.

The form of proxy or a voting instruction form, along with a description of the matters to be addressed at the Meeting (collectively, the "Notice Package") were mailed to Village Farms' shareholders on or about May 30, 2024. Shareholders who have not yet received their copy of the Notice Package should contact their broker if they are a non-registered shareholder or contact Computershare if they are a registered shareholder.

In Canada, the Company's wholly-owned Canadian subsidiary, Pure Sunfarms, is one of the single largest cannabis operations in the world, the lowest-cost greenhouse producer and one of Canada's best-selling brands. The Company also owns 80% of Québec-based, Rose LifeScience, a leading third-party cannabis products commercialization expert in the Province of Québec.

In the US, wholly-owned Balanced Health Botanicals is one of the leading CBD brands and e-commerce platforms in the country. Subject to compliance with all applicable US federal and state laws and stock exchange rules, Village Farms plans to enter the US high-THC cannabis market via multiple strategies, leveraging one of the largest greenhouse operations in the country (more than 5.5 million square feet in West Texas), as well as the operational and product expertise gained through Pure Sunfarms' cannabis success in Canada.

Internationally, Village Farms is targeting selected, nascent, legal cannabis and CBD opportunities with significant medium- and long-term potential, with an initial focus on the Asia-Pacific region and Europe.
